



What is the B.Comm./JD Combined Degree Program?

The B.Comm./JD program allows a student to obtain both the Business and Law degrees in six years rather than the seven years needed to complete the degrees separately.

This program works well for those students majoring in areas of business that require 18 credit units for completion (OM), but can be completed in any major.

All students should speak with an Edwards Undergraduate Programs Advisor about their options.

Completing the Program

A student initially applies to the Edwards School of Business and spends three years completing the core and major classes within the Bachelor of Commerce program.

The student applies to the College of Law in their third year of business classes. If a student is admitted to Law, they would complete the regular three year Law program and would be eligible to obtain their B.Comm. degree after successfully completing two years in Law. **Students accepted to Law are no longer Edwards students and are not eligible to receive or apply for Edwards awards.**

NOTES

- ▶ Admission to Law is not guaranteed
- ▶ If a student is not admitted to Law, they spend their fourth year at Edwards and graduate with a B.Comm. degree
- ▶ Students following this program would not take the Business Law classes COMM 304.3 & 404.3
- ▶ **Students are still required to complete 12 credits of junior Social Sciences or Humanities**
- ▶ **Students following this program must complete at least 90 credits as a student in the B.Comm. program**

Exemption from B.Comm. classes (30 credits)
18 credit units of senior free electives
6 credit units of junior non-commerce electives
3 credit units of senior non-commerce electives
3 credit units of COMM 402: Business Negotiations
<i>*Accounting students must take COMM 321 and 323 in Spring & Summer between year 2 and 3</i>

Accounting (2016 and beyond)
Exemption from B.Comm. classes (21 credits)
9 credit units of senior free electives
6 credit units of junior non-commerce electives
3 credit units of senior non-commerce electives
3 credit units of COMM 402: Business Negotiations
<i>*COMM 321 & 323 plus 3 other credit units (COMM 306 or 307 suggested) must be taken in Spring & Summer between year 2 and 3</i>



Finance & Marketing
Exemption from B.Comm. classes (30 credits)
21 credit units of senior free electives
6 credit units of junior non-commerce electives
3 credit units of senior non-commerce electives

Management
Exemption from B.Comm. classes (24 credits)
12 credit units of senior free electives
6 credit units of junior non-commerce electives
3 credit units of senior non-commerce electives
3 credit units of COMM 402: Business Negotiations
<i>*6 credit units still to be taken in Spring or Summer to complete required B.Comm. classes</i>

Operations Management
Exemption from B.Comm. classes (30 credits)
24 credit units of senior free electives
6 credit units of junior non-commerce electives
