

Faculty Job Posting Form

Applications are invited from qualified individuals for five (5) full-time one-year limited term positions at the rank of Lecturer or Instructor with the Department of Finance & Management Science, Edwards School of Business, University of Saskatchewan located in Saskatoon, Canada:

- (1) **Business Mathematics (BMath)**: This is a <u>one-year term</u> starting July 1, 2023. The successful candidate will be required to develop and deliver introductory and advanced business mathematics courses; engage with faculty, students, and community partners; and contribute to collaboration between instructors.
- (2) **Business Statistics (BStat)**: This is a <u>one-year term</u> starting July 1, 2023. The successful candidate will be required to develop and deliver introductory and advanced business statistics courses; engage with faculty, students, and community partners; and contribute to collaboration between instructors.
- (3) **Management Information Systems (MIS)**: This is a <u>one-year term</u> starting July 1, 2023. The successful candidate will be required to develop and deliver introductory and advanced management information systems courses; engage with faculty, students, and community partners; and contribute to collaboration between instructors.
- (4) **Operations Management (OM)**: This is a <u>one-year term</u> starting July 1, 2023. The successful candidate will be required to develop and deliver introductory and advanced operations and supply chain management courses; engage with faculty, students, and community partners; and contribute to collaboration between instructors.
- (5) **Personal Financial Management (PFin)**: This is a <u>one-year term</u> starting July 1, 2023. The successful candidate will be required to develop and deliver introductory and advanced finance courses; engage with faculty, students, and community partners; and contribute to collaboration between instructors.

Note that the teaching load for these positions is nine (9) courses per year (typically 4-4-1).
